- 1. <u>ePrivacy</u>: regulates the processing of personal data in electronic communications
  - Obtain consent before using cookies\* (*e.g.*, preferences, statistics, marketing)
- 2. ePrivacy 2009: Consent  $\Rightarrow$  explicit and informed consent
- 3. GDPR: Extraterritorial scope

- 3. Potential **break of trust** among citizens and authorities









# Approach

#### 1. Visit websites

- collect cookies with an instrumented web browser
- 10 URLs per website
  - only HTML content and clickable hyperlinks
- NO consent given (or any action performed)


1) More than  $1^*$  out of 3 of websites set Third-Party cookies for 11 out of 19 countries this ratio is  $\geq 50\%$ 




Takeaway:

2) TP and TPT cookies last longer the FP



#### **Source Selection**

#### 1. G20 Governmental websites:

- <u>no</u> crawling + inferring *if* the website is governmental
- official sources (e.g, https://administracion.gob.es/pag\_Home/atencionCiudadana/ SedesElectronicas-y-Webs-Publicas/websPublicas.html)

#### 2. International organizations:

- agencies from the EU and UN websites
- major recognized international organization
- 3. Covid-19:
- URLs from the US Center for Disease Control and Prevention
- URLS from the EU Center for Disease Prevention and Control
- SimilarWeb to find the covid-related websites for each one of the G20 countries


Use of filter lists:

- 1. Disconnect (Firefox tracking protection)
- 2. Privacy Badger (from EFF)
- 3. EasyList, EasyPrivacy and Adguard (community maintained)

NOTE: Conservative approach; our results as lower bound:

- bias toward well-known Western trackers
- tracker IIF "the full domain appears in a filter list"
- majority vote on trackers
